#### A. Station 1-2 - (update)

## 11. NEW BUSINESS

#### A. EJFR CARES

Chief Black gave a Power Point presentation on EJFR CARES. This is a grant funded program that focuses on the needs of people who have underlying behavioral health and/or medical and/or lifestyle issues (but without a need for police intervention). The objectives are to; (1) improve the standard of care for individuals in behavioral health crisis reducing recidivism, promoting non-hospital alternatives to individuals with behavioral health needs, (2) ensuring overlapping issues are addressed and appropriately referred and (3) prevent crisis by addressing underlying behavioral/medical/social needs that—when unmet—lead to the use of 911 and emergent situations. The CARES unit will be staffed with an EJFR FF/EMT or PM and a CARES Believe in Recovery co-responder. Commissioner Tillman and Chief Black attended a meeting of a group of other entities that have the same program. This group shares ideas and lessons learned to make the program stronger. The CARES vehicle would be in operation four, 10 hour days, Monday through Thursday.
